AMENDMENT TO THE JOINT ZONING ORDINANCE OF NORTH HEIDELBERG TOWNSHIP, HEIDELBERG TOWNSHIP, THE BOROUGH OF ROBESONIA, AND THE BOROUGH OF WOMELSDORF, BERKS COUNTY, PENNSYLVANIA, TO AMEND THE ZONING MAP TO REZONE THE AREA IN NORTH HEIDELBERG TOWNSHIP CURRENTLY ZONED HC-HIGHWAY COMMERCIAL DISTRICT TO MDR-MEDIUM DENSITY RESIDENTIAL DISTRICT

WHEREAS, the governing bodies of North Heidelberg Township, Heidelberg Township, Robesonia Borough, and Womelsdorf Borough enacted the Joint Zoning Ordinance effective January 10, 2004; and

WHEREAS, in order to meet the needs of North Heidelberg Township for additional residential development, and in consideration of the lack of interest in developing the current HC-Highway Commercial District of North Heidelberg Township for commercial purposes, the governing bodies desire to amend the zoning map by re-zoning the existing HC-Highway Commercial District in North Heidelberg Township as MDR-Medium Density Residential District.

NOW THEREFORE, BE IT ENACTED AND ORDAINED by the Boards of Supervisors of the Townships of North Heidelberg and Heidelberg, and the Borough Councils of the Boroughs

of Robesonia and Womelsdorf, Berks County, Pennsylvania, that the Joint Zoning Ordinance of 2004, as amended (the "Joint Zoning Ordinance"), is hereby amended as follows:

Section 1. Pursuant to the Joint Zoning Ordinance, Section 303, entitled "Zoning Map", paragraph B, entitled "Map Changes", the Zoning Map of the Joint Zoning Ordinance shall be amended to change the existing area of North Heidelberg Township zoned as HC-Highway Commercial District to MDR-Medium Density Residential District. Said change shall be noted by date with a brief description of the nature of the change, either on the existing Zoning Map or within an appendix to the Joint Zoning Ordinance.

Section 2. All other provisions of the Joint Zoning Ordinance shall remain in full force and effect.

Section 3. <u>Repealer.</u> All ordinances or resolutions or parts of ordinances or resolutions which are inconsistent herewith are hereby repealed.

Section 4. <u>Severability.</u> If any article, section, subsection, part, provision, regulations, limitation, restriction, sentence, clause, phrase or word of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining article, section, subsection, part, provision, regulations, limitation, restriction, sentence, clause, phrase or word of this Ordinance. The Municipal governing bodies hereby declare that they would have enacted this Ordinance had such unconstitutional, illegal or invalid article, section, subsection, part, provision, regulations, limitation, restriction, sentence, clause, phrase or word thereof not been included herein.

Section 5. Effective Date. This ordinance shall become effective five days after enactment.
