Roads, Building & Equipment -

- Road Work Update: Big Spring Rd complete. Steeple Drive has two soft spots that need to be addressed. Both areas need to be painted.
- PPL LED Light Conversion: Light conversion complete minus 4 poles in Fry Manor. Secretary Werner has contacted PPL to correct.
- Chapel Ridge Estates: Street lights need to be painted along with stop/speed sign posts.
- Road Signs: Fry Manor and Brossman Heights need stop/speed signs replaced.

NEW BUSINESS:

DCR Ordinance, Regulations Governing Disruptive Conduct for Rental Property Tenants: Presented by Sargent Hackney. The DCR gives the Township authority to evict if there are 3 offenses within a 12 months' time. Judge Young is aware and in in favor. Chairman Randler stated the Township does not have a rental program in place, asked how the DCR would be tracked and does not agree a lease agreement should be needed to enforce. He suggested removing the section discussing tenant to sign lease agreement. Sup Snyder suggested setting up a rental program in the Township which would require an Ordinance be passed.
