NEW BUSINESS:

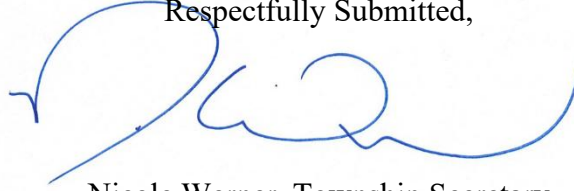
